- **Please note, Safety Town of Santa Barbara County reserves the right to cancel sessions due to enrollment numbers. You will be notified if this occurs.**
- A parent/guardian must attend an important parent orientation meeting on the first scheduled day, Monday, from approximately 8:30-9:00 a.m.
- Refunds will only be made if we are able to fill your child's slot with another child from our waiting list. There is a **\$25 cancellation fee.**
- **There is a \$25 Transfer fee to change session. One transfer allowed.**
- All students must wear their Safety Town shirts and closed toe shoes daily. It is recommended your child have sunscreen applied before arrival, wear a hat, and bring a labeled water bottle.
- Pick up – please **arrive BY 12:00 p.m.** each day. A fee of **\$25** will be charged for **every 15 minutes** you are late picking up your child.
- Participants must be able to follow simple instructions. Inappropriate and/or unsafe behavior may be grounds for dismissal from the program.
