In accordance with California Consumer Privacy Act and the provisions of the Children's Online Privacy Act, we may collect and store other personal information about children if this information is submitted by the parent or guardian of the child. A parent may review and have deleted their child's Personal Information, and may refuse to permit further collection or use of their child's information by contacting us as noted at the end of this page. Parents may consent to our collection and use of their child's Personal Information without consenting to the disclosure of that information to others.

A parent who has already given the Company permission to collect and use his/her child personal information can, at any time:

- Review, correct or delete the child's personal information
- Discontinue further collection or use of the child's personal information

You are entitled to request us to erase any personal data we hold about you under EU General Data Protection Regulation (GDPR).

## **GDPR Article 8**

Where point (a) of Article 6(1) applies, in relation to the offer of information society services directly to a child, the processing of the personal data of a child shall be lawful where the child is at least 16 years old. Where the child is below the age of 16 years, such processing shall be lawful only if and to the extent that consent is given or authorized by the holder of parental responsibility over the child. Member States may provide by law for a lower age for those purposes provided that such lower age is not below 13 years.

Safety Town of Santa Barbara County (STofSBC) does not consistently use, sell, or market-research data after summer session has completed. Current parents/ guardians can log into RegPacks to review, correct or delete child's personal information. Safety Town will retain *Your Personal Data* only for as long as is necessary, approximately 2 years. We will retain and use *Your Personal Data* to the extent necessary to comply with our legal obligations, state and local regulations, resolve disputes, and enforce our legal agreements and policies. Safety Town of Santa Barbara County will neither share nor sell your contact information to another organization, business, or individual for solicitation, marketing, or other purposes unrelated to STofSBC business for any reason at any time. Safety Town of Santa Barbara County will not send mailings/emails on behalf of other organizations, businesses, or individuals that are unrelated to STofSBC business. You have the right to opt out from the Safety Town's mail/email list by written request at any time.\*\*
